Please bring original and photocopy of your documents.

Please print a copy of this notice and proceed to the Guard-On-Duty to get a schedule for Step 2 DHAD approval, encoding, releasing, payment of POEA processing fee (PhP equivalent of US\$100.00) and OWWA membership (PhP equivalent of US\$25.00). For workers who were processed at the POEA Regional Offices, your OECs shall be processed through the POEA Regional and Overseas Coordinating Office.

Direct hire applications with occupations under the low skilled category are advised to seek the assistance of the Accredited Licensed Private Recruitment Agencies (PRAs) in the facilitation of your application.
