  - Willing to undergo the six (6) months Preparatory Japanese Language Training in the Philippines (live-in); **or**
  - With Japanese Language Proficiency Training Certificate (JLPT N4 or N3)
- Must be interested and motivated to work and study as candidate for “Kangoshi” to obtain a national license in Japan.

**CAREWORKERS**

- Graduate of any four (4) year course but with National Certificate (NC II) in Caregiving from TESDA;
- Graduate of Bachelor of Science in Nursing (with or without board license);
- Must be medically and psychologically fit to work.
